Willapa Bay Update



On August 3rd, CCA Washington sent a letter to the Washington Commission which outlined concerns with the draft Willapa Bay Salmon Management Policy and provided concise recommendations for incorporation into the draft policy. We also initiated an Action Alert that generated nearly 300 individual e-mails to the Commission.

The Commission discussed the Willapa Policy during their August meeting. This included a very short presentation by WDFW staff that was severely lacking in substance and, as expected, displayed a bias in favor of non-selective gillnets. While there was no vote, the Commission indicated that they would be moving forward with the draft policy, which is

nothing more than continuing the status quo of overharvest in non-selective gillnets and chronic missed escapement goals on the spawning grounds.

Without any complications with tribal co-management, and no current ESA listings, Willapa Bay is the poster child for how WDFW envisions fisheries should be managed. This is yet another example of why our salmon and steelhead will never recover under the current status quo management regime at WDFW.

2023 Baker Lake Sockeye Shootout



The Skagit River system and Baker Lake experienced a significant return of sockeye this year, resulting in excellent fishing conditions and a successful derby. The total count of sockeye transported to Baker Lake exceeded 31,000 by the end of the season. The successful season, which brought benefits to numerous anglers, can be largely attributed to the early efforts undertaken by CCA North Sound, Puget Sound Energy and our friends at Puget Sound Anglers. Without the dedicated work of our collective volunteer efforts, this year's remarkable returns would not have been possible. A special thanks is owed to Bob Cooper from the CCA North Sound chapter.

At least one group of first-time anglers at Baker Lake not only achieved a "triple," but also had the privilege of landing a tagged fish simultaneously. You can watch the video by CLICKING HERE.

Holding ODFW Accountable



CCA Oregon and Washington appreciate the efforts of the Siletz Angler Association and others to hold the Oregon Department of Fish and Wildlife accountable for providing sustainable recreational fishing opportunities in Oregon's coastal rivers. The Siletz Angler Association lawsuit complements efforts by CCA and others to reduce the

extensive harvest of Northwest salmon populations in commercial fisheries off the coasts of Alaska, British Columbia, Washington and Oregon.

The need for change has become clearer than ever as ODFW and WDFW continue reducing recreational fishing opportunity in our rivers, including many mark-selective fisheries managed to protect wild salmon populations, while enabling the extensive, non-selective commercial harvest of many of these same populations.

We must come together to hold public agencies accountable for meeting the conservation needs of Pacific salmon populations and providing more equitable fishing opportunity in our coastal waters and rivers through the various regional and international fishery management bodies.
